- The RSUs vest as to 1/4 of the RSUs on September 15, 2019 and 1/16 of the RSUs will vest each three months thereafter such that the RSUs are 100% vested on September 15, 2022.
- The restricted stock units vest at the rate of 1/12 per quarter commencing on March 15, 2020.
